I'LL LEAVE THE ANALYSIS TO THE SGT.

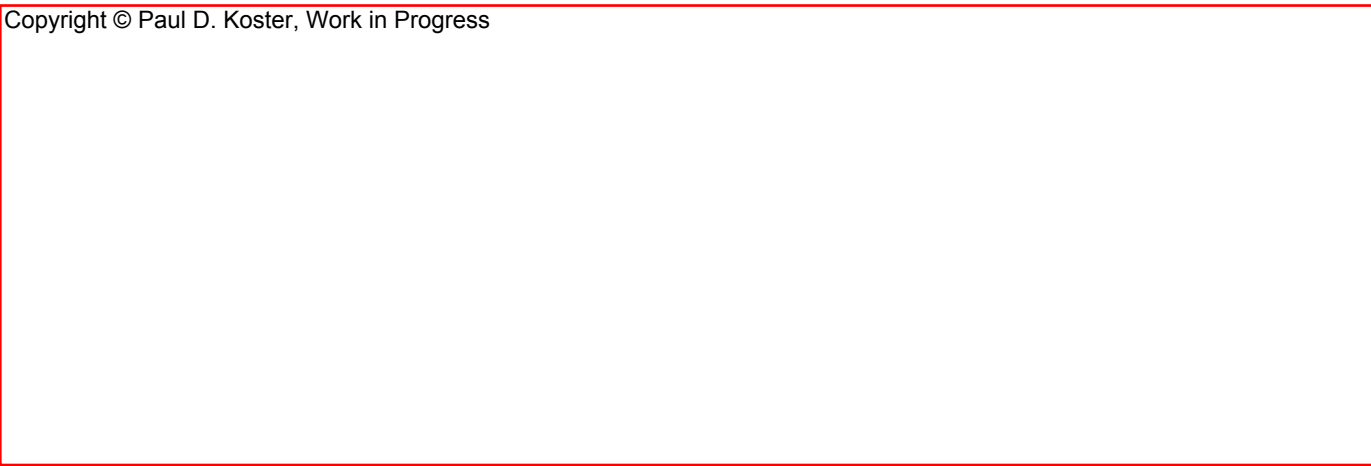
